

If a police officer gives you a signal that is different from the posted traffic signs or signals, you must obey the police officer.

- **2** You must yield to anyone on bicycles on bike paths, even where the bike paths cross into the road you're driving on
- Any blind pedestrian walking with a white cane or a 3 guide dog has the right of way, no matter what the situation is.
- When turning left, you are required to yield to vehicles going straight.
- When waiting to drive through a rotary or traffic circle, the vehicle already in the rotary or circle has the right of way.
- At a 4-way stop, the car that arrives first has the right of 6 way.
- 7 You may not cause gridlock do not enter an intersection if it is going to block traffic. You must be able to pass all the way through.

# IMMIGRATION

President Biden has overseen a record number of illegal border crossings with a seemingly difficult time implementing his policies. Immigration court delays continue to plague millions of immigration cases, thousands of immigrants have been deported under title 42, and DACA continues to face court challenges. In every attempt to improve the immigration system, the Biden administration has faced upheaval from Republicans and numerous court challenges. With the House of Representatives soon to fall under Republican control this divide will only strengthen and undocumented immigrants are unlikely to see any meaningful legislative change for years. ### ERS' COMP WORK

Getting injured on the job can put one in a difficult predicament. Your livelihood is tied to your work and when this is affected by an injury your concerns are warranted. Your priority after a work injury should be to recover not continue to exacerbate the pain in fear of retaliation from your employer. Rest assured your employer cannot fire you for making a work injury claim. In Connecticut, your employer is legally required to carry workers' compensation coverage. This form of insurance is designed to compensate injured parties for their medical treatment and lost wages. Workers' Comp is meant to provide essential benefits for injuries that were a result of your employment. When injured at work, here's what you should do immediately.

### NOTIFY YOUR EMPLOYER OF INJURY

You need to notify your employer of your injury as soon as possible. It is important to note that you have a limited amount of time to bring a claim against your employer. You should get in touch with an attorney as soon as possible to make sure you can begin the claim process promptly. Proper notification of your injury to relevant parties will ensure processes are followed. If you are unsure about whom to contact or what to do, consider reaching out to your manager or an attorney.

### SEEK MEDICAL ATTENTION

After an injury, your immediate priority should be to seek proper medical attention. Work injuries can be a debilitating experience. Visit your local hospital and get yourself treated for all injuries. Even after being released from the hospital, you should seek the attention of your doctor as some injuries may go unnoticed. For example concussions, spine injuries, and rotator cuff tears can go unchecked in an emergency room. Proper documentation of your injuries is an important part of your claim.



### Cooking Directions BY BETTY CROCKER™ KITCHENS

In large bowl, mix 1 & 1/2 cups powdered sugar, the butter, I teaspoon vanilla, almond extract and egg until well blended. Stir in flour, baking soda and cream of tartar. Cover and refrigerate at least 3 hours.

Heat oven to 375°F. Divide dough in half. On lightly floured surface, roll each half of dough 3/16 inch thick. Cut into assorted shapes with cookie cutters. Place on ungreased cookie sheet.

Bake 7 to 8 minutes or until light brown. Remove from cookie sheet to cooling rack. Čool completely, about 30 minutes.

In medium bowl, beat all frosting ingredients until smooth and spreadable. Tint with food color if desired. Frost and decorate cookies as desired with frosting and colored sugars.
